- Signature Card changes – Progress has been made in addressing the business process of making changes to existing signature card forms. We hope to have a smoother solution in the coming months.

Campus Directory Update

The Campus Directory WEB application is being re-written. The *Beta* version is located at: <http://people.utah.edu/>. The *Beta* version was demonstrated. BPAG members are encouraged to use the *Beta* version and give feedback to: Dir-beta@unite.utah.edu. - Improvements include:
 - Single Box search.
 - Employees who go by middle names can be located.
 - Unknown spellings can be found because of Soundex technology.

ARRA ARRA Update

- The first ARRA report is due to the Federal Government by October 10, 2009. The University of Utah has met that deadline. Reports are due quarterly on the 10th of the month following the end of a quarter.
- Project Lookup now has the ability to search for ARRA projects.

e-Journal Update

- Demonstration of the web interface application:
 - Journals pending action by you are displayed on the main screen
 - Creation of new journal demonstrated
 - Ability to share journals demonstrated
 - Departmental Approvals will follow the same guidelines currently in place

EBT Update

- Activity and Project by ORG EBT's are in the final stages of development and should go live after security is setup.
- EBT by BU 02 and 03 is in development.
- "Troubleshooter" EBT – Query by given employee is in development.
- Question on if the payroll distribution dates/% are being used on the Encumbrance reports. There was consensus that the data is needed, but it should be omitted on the FIL/HRIL encumbrance EBT's in cases where the employee has multiple distributions on the same chartfield. It is more important that the FYTD Actuals and Encumbrance amounts are accurate.

Going Back (Forward) in Time

- Adding arrows to the month on Management Reports, so the user can go back or forward by a single month was discussed. The group thought this was a good idea.

Excel Pivot Table Demo

- Pivot tables in Excel were demonstrated. Pivot tables can be valuable when analyzing EBT data or any other data you wish to summarize. (PowerPoint Presentation follows minutes)

"Sortable" columns in UofU WEB Apps

- A new sorting feature was demonstrated for the UofU WEB applications. If the shift key is held down while selecting columns, multiple sorts can be applied. The sorts are ordered in the sequence they are selected after the shift key is held down.
