Non-Catalog Form

- o This form was reviewed. Please provide feedback on how this form can be improved or enhanced.
- The "Non Catalog Quick Order" was mentioned, and some like it quite a bit, although they feel like it's a bit hidden on the shopping home page.
- Turnaround time from Radioactive Health to approve radioactive orders takes too long. Deni in Biology shared a specific example to illustrate delayed processing.

Dashboards

- o Dashboards reviewed. The feedback received was positive.
- o Better if the Action Items widget can be placed higher in the dashboard.
- o These should be explored. This will likely require modification of the existing role structure.

Training

- Response to online Shopper training videos was positive. It's easy for users to get retrained whenever they need.
- We should proceed with developing online Requisitioner training.
- Can UShop provide real-time chat support to end users?
- Can simple, very short, punch-out-only training videos be created?

Supplier

- Sigma-Aldrich punch-out coming soon, as is Life Technologies
- o Problems surrounding ship-to locations was discussed

Management Reports

- Dean reviewed proposed functionality in management reports that will combine many separate UShop transactions, making management report review easier. Response was very positive.
- Should individuals who are not Employees (e.g. students) be provided access to UShop? The consensus was yes. Dean not exactly sure how this will be handled.

Security

Scott reviewed how to manage secure information and encouraged everyone to review the <u>Data</u>
<u>Classification and Encryption Rule</u>. The recommended approach is to simply avoid putting sensitive information into UShop.

Other items

Several users would like to be able to extend GFA authority on a limited basis to users, where they would have some limited authority, for procurement only, but their authority would not extend to other financial transactions. This would require significantly rewriting current GFA and instead it was suggested that modifying user roles and permissions in UShop might be a way to handle this. Perry will explore this further as part of his work on analysis of the existing user roles and permissions.
